The £1.1m UKRI funded [SAFESOC](#) research project aims to reconceptualise prison regulation for safer societies. This difficult multidisciplinary challenge demands academic innovation. Implementation requires sustained collaboration with local and (trans)national practitioners from different sectors (e.g. public, voluntary), regulators, policymakers, and prisoners. Based at the [University of Nottingham](#), SAFESOC is generously funded through Dr Philippa Tomczak's prestigious [UKRI Future Leaders Fellowship](#), and sits within the '[Prisons, Health and Societies](#)' Research Group. This study runs from 2020-2024.

## Spotlight - Dr Gill Buck's highlights



### **What was your personal original goal or understanding of what your contribution would be?**

I had been working on lived experience involvement in criminal justice (i.e., how people draw on experiences of criminalisation to design, deliver and influence criminal justice practice). I was originally excited by the opportunity to examine ways that prisoners, former prisoners and their families regulate – or could regulate – prisons.

**What were the challenges involved?**

A huge challenge was the Covid pandemic. We had originally planned lots of in person fieldwork including drama-based ethnography, but this became unsafe as lockdown happened. In response, we rapidly redesigned fieldwork and arts practices to include online focus groups, collaborative authorship and a verbatim film, which was screened online (and in person once restrictions were lifted). We have supplemented this collaborative work with desk-based documentary research and critical co-reflections with lived experience partners.

**What was your personal highlight?**

I loved working with the experts by experience. First as critical co-authors reflecting on [peer-led suicide prevention in prisons](#), then as film and theatre co-creators, who took important messages about prison suicide to a broader audience, including parliamentary decision makers.

**What have you learned?**

I have learned the value of documentary research, for example, how the [successes and failures](#) of regulatory efforts can often be found in historical documents, and perhaps as criminologists (and social workers) we too often overlook these treasures. I have also learned that professionals in other disciplines (e.g., the arts) have a range of skills and techniques that we can learn as social scientists to enhance our own ethical and engagement practices.

**What are your feelings about the project coming to an end?**

I am really sad. I have loved working with the team and having protected time to focus on and analyse the potential of participation. I am also grateful to have had this opportunity and am motivated to continue with participatory forms of research.

## 'Improving prisoner death investigations and promoting prison safety' event, October 2023



The [Improving prisoner death investigations and promoting prison safety](#) event was hosted at the House of Lords by Professor Philippa Tomczak and the University of Nottingham SAFESOC team, on the 24th October 2023. The event showcased a verbatim film documenting the lived experience of a family bereaved by prison suicide and facilitated reflections and provocations from the Woodhill Families' Group – a collective of families who have lost loved ones in prison. Drawing on research by Professor Philippa Tomczak into prison death investigations, the event also launched a short policy brief to inform prison regulators and policymakers. The event was attended by over 70 representatives including parliamentarians, policymakers, the Prisons and Probation Ombudsman, Inspectors and Coroners, prison staff, health and social care staff, voluntary organisations, academics and people who have been personally impacted by deaths in prison.
